Everett McKinley Dirksen Parkway, Peoria, IL 61607 for furnishing all labor, materials and equipment, and performing all work for **Airport Traffic Control Tower (ATCT) Facility**, located at the Peoria International Airport.

The work to be done under this contract includes the furnishing of all labor, material, equipment, tools, and all associated work necessary for the construction of the above referenced project. The work generally includes: New Airport Traffic Control Tower (ATCT) including Tower (23' X 23', 9 story, 8000 SF, 146' tall), Base Building (180' X 80', 14,560 SF, single story) and associated Site/Paving/Utility Work.

Each proposal must be accompanied by a bid guaranty in the amount of **five (5) percent** of the total amount of the bid. The bid guaranty may be by certified check or bid bond made payable to **Metropolitan Airport Authority of Peoria**.

Prospective Bidders are hereby advised that award of contract and start of work is contingent upon the Owner receiving approval and adequate Federal funding assistance from the Federal Aviation Administration (FAA).
